5. Public Hearing on the 2025 Fiscal Year Ending Budget

- Treasurer Georgiades answered questions.
- The new budget year will start on October 1st, 2024.

- Treasurer Georgiades reported that \$320,580 is currently being held in reserve, earning ~\$1,500 interest per month. The District has been budgeting money for the reserve account since the recreation district tax increase, \$50,000 in this proposed budget.
- Treasurer Georgiades made a **Motion** to Adopt the 2025 Fiscal Year Ending Budget, based on the District Tax Rate of \$800.00 to be assessed and collected upon the Taxable Property of the District for 2025-FYE.

Original Carrollwood Park Chair Lavisky

- The District's maintenance employee Gary Greene suggested to Trustee Lavisky the idea of moving the fence near the dog park entrance back further to allow more room for parking.
- The board discussed this.

- o If there is a demand, we should wait until the whole fence is done in the 2025-2026 fiscal year, however, the board does not think there's a big need for this now.
- o It would increase traffic and there's not a lot of room to back out of the area.
- o That area isn't a designated parking area, residents should use the parking lot at the Recreation Center.
- A sign was suggested that says this area is not a designated parking area and parking is at the owner's own risk.

White Sands Beach Chair Shidler

- Lab results from the swim side are good.
- Board discussion on shade coverage and a more permanent structure for the guard at the front entrance.
 - o Anything permanent or attached to the fence will need permitting.
 - o A tent and fans can be removed much easier to manage.
- On Monday, June 17th, the center wall where the guard sits under the oak tree will be demolished. It's a one-day demo and it was suggested that White Sands Beach be closed for the day.
- On Wednesday, June 19th, the new fence will be installed.
- A resident, Shirley Pearsall, will be providing landscaping ideas. She'll provide recommendations on plants and landscape lighting.
- Focus will be the fence first, then landscaping and lighting last.

Scotty Cooper Park Chair Griffie

• Not present.

Grounds Chair Seeley

- The Board discussed some parking issues on the street in the median on Lake Carroll Way.
 - Some board members live in the area & know it can be busy at times.
 - O Sheriff has been called in the past and there's not too much that can be done. A car can be parked for 3 days without moving.

Community Development Chair Jared Brown

- July 4th activities at White Sands Beach are coming up, the grounds will be spruced up and sprayed for ants.

9. Other Business

- Reopened Public Comment, but no public was in attendance.
- A non-resident made a public records request & contacted our general counsel to request the District's 2014 loan documents, and wanted to know if the loan was tax free and asked about a non-resident membership fee.
 - The general counsel provided the person with our original loan documents. Per the state law that governs the CRD, the District has never changed or deviated from the law that was adopted by the Florida Legislature in 1972. The Legislature restricted the use to residents, nonresident property owners, and family & guests.
 - o In the past, we've had non-residents ask about fees to use the amenities.
 - Older residents that don't use the facilities have asked about their adult children being able to use the amenities.
- Continued board discussion on the Umbrella policy and concerns of a judgement that could attach the community properties in a litigation settlement.
 - The CRD reached out to the CCA about changing title of ownership for the Recreation Center, White Sands Beach, and Scotty Cooper Park to the CRD, to better protect the assets from a judgement. The CRD has sovereign immunity limited to \$200,000 as a governmental entity per state law, whereas the CCA does not.
 - The CRD will ask if both boards' general counsels could attend a future CRD meeting so both boards are fully aware of the legality and laws regarding the land that is owned and leased between the boards.
 - We do not know all the facts and rules without getting the attorney's involved and the CRD Board agrees that it's worth further discussion between both boards.
